Mrs Hancock, 10 Lynwood Road, Lydney – Planning application P0263/17/FUL – expressed concern over the exact location of the boundary line for the proposed development in the Public House's car park. Concern was also expressed that insufficient parking had been included in relation to the proposed new car park so as to cater for clientele of the Public House.

8. TREE PRESERVATION ORDER

P0527/17/TPO - Miss K Daniels, 7 Bledisloe Way, Lydney 20% Crown reduction of x 1 Scots Pine tree covered by A2 of TPO172 No objection

9. PLANNING APPLICATIONS

P0263/17/FUL - Ms K James, Severn View Inn, Lynwood Road, Lydney Erection of two dwellings and associated works in the current car park for the public house. Provision of a new car parking area to the rear of the public house No objection. Council are however concerned that the proposed new car parking area which is to serve the Public House will not provide sufficient parking for patrons at peak times, necessitating on street parking in Lynwood Road and surrounding areas which may cause difficulties with the flow of traffic and restricted access for existing dwellings. Furthermore, the two junctions of Lynwood Road with Primrose Hill Road require vehicles to make difficult turns with limited visibility in order to exit Lynwood Road; Council call for the opinion of Gloucestershire Highways Department to be sought in order that the current situation is not exacerbated by the proposed development.

Finally, District Councillor Preest has given a commitment to arrange for the application to be referred to Forest of Dean District Council's Planning Committee in order that a site visit may be conducted by Members.

P0481/17/FUL – Mr Daliel, Land South of A48 Bypass, Lydney Bypass Middle, Lydney Creation of an access and associated groundworks (part-retrospective)

Objection. Council believe that the proposal will create a flood risk for the parish; watercourses in our parish are already over-subscribed at times of adverse weather and Council feel that the culverting of Plummers Brook, which is contrary to Lydney's adopted Neighbourhood Development Plan, will be detrimental to our Town. Guidance from the Environment Agency with regard to the flood zone map for Lydney suggests that such application requires a hazard rating/flood risk assessment which we note has not been included with the application.

Furthermore, the view of the Local Lead Flood Authority, Gloucestershire County Council, must be obtained on the proposal.

Council also objects to the creation of a vehicular access on the grounds of highway safety. The site is close to the roundabout for the Oakdale site which vehicles regularly drive over, therefore Council believe that the proposed access would be a distraction to drivers using the A48 carriageway.

It was unanimously agreed that the CEO would also contact the Officer concerned to request that the Council be provided with exact details of the levels which had been recorded at the three locations with the highest levels of pollution, rather than receive a generic description. Responding to a question which had been raised by Cllr Greenwood, Cllr Preest advised that the Local Enterprise Partnership would fund the signalling of the Bream Road Junction in the 2018/2019 financial year.
