## 8. TEMPORARY ROAD/FOOTPATH CLOSURES, CREATIONS/DIVERSIONS

Temporary Road Closure – outside 87 Naas Lane to junction with Naas Lane/A48 (total distance of 0.78 kilometres) from 8 August 2016 to 5 September 2016 or until the works have been completed.

## 9. HIGHWAY CORRESPONDENCE

 Gloucestershire County Council – E-mail from Harry Ives, Programme Officer, advising that the Lengthsman Scheme would continue in Lydney W/C 1 August 2016 and inviting suggestions as to specific work/tasks which could be addressed under the scheme.

During discussion Cllr Pugh highlighted that the Hams Road Car Park was being used as a meeting place by youths with cars and he expressed concern over the amount of litter which was being left in the area. Members were informed that the matter had already been brought to the attention of Gloucestershire Police. It was noted that the land was managed by Lydney Recreation Trust who engaged the services of a contractor to routinely litter pick the site, however, Members requested that the Trust's attention be brought to the current problem.

P1881/15/FUL – Land East of Par Four Lane, Lydney

Revised Plans – Erection of 347 residential units, access and highways, open space, landscaping and associated infrastructure comprising phase 2 "Higher Lydney Park" Objection. Council wishes to reiterate its previous concerns regarding drainage on the site and the effect that the proposed scheme will have on the neighbouring watercourses/existing properties in Lakeside Avenue. Council is also aware that problems are already being experienced with flooding on phase 1 of the development and requires an assurance from the Local Lead Flood Authority that the revised plans submitted in respect of the Surface Water Strategy Plan are acceptable, sustainable and maintainable (long term maintenance programme in place). Accordingly, Lydney Town Council would request a meeting with the Applicant and representatives from the Local Lead Flood Authority and Severn Trent to discuss the proposals before giving its approval.

Council would draw attention to the fact that not all the revised plans which it has received have been scanned to Forest of Dean District Council's website; the Surface Water Strategy Plan, Bat Aerial Tree Inspection, Swept Path Analysis – Refuse Vehicle, Proposed Masterplan Visibility Splays, Type 6 Type 7, Tree Retention/Removal – Plan 1, tree Retention/Removal – Plan 2, Tree Retention/Removal – Plan 3, Proposed Phase 2 – Parking Proposals – Sheet 1, Proposed Phase 2 – Parking Proposals – Sheet 2, Soft Works Plan, General Arrangement, Proposed Phase 2 – Masterplan do not appear to be on Forest of Dean District Council's website preventing informed party discussions.

- E-mail from Edward Argent, Robert Hitchins Limited advising that they had commenced archaeological works on their site off Highfield Road; that it was their intention to make a construction site start later in the month; that the construction of the new site access will commence following the establishment of the compound. Mr Argent gave a commitment to regularly keep the Council informed on the progress of the works and offered to arrange a site visit for Councillors once the site was up and running. Noted.

## 13. COUNCILLORS REPORTS

Cllr Pearman expressed concern over the condition of the junction markings for Bream Road/High Street, Albert Street/Newerne Street and Hams Road/Newerne Street. Furthermore, concern was expressed that an accident would shortly occur at the Albert Street/Newerne Street and Hams Road/Newerne Street junctions due to a failure to observe the "stop" instructions by drivers. The CEO was requested to refer the matter to Mr Brian Watkins, Gloucestershire Highways in order that the condition of the road markings could be inspected

Cllr Christodoulides reported 2-3 potholes in the vicinity of Mount Pleasant, close to Leaze Court. County Cllr Preest gave a commitment to report the potholes to Gloucestershire Highways.
