Lydney Youth Council is a newly formed addition to Lydney's existing Town Council.

The Youth Council is taken from schools all over the Forest Of Dean and all of our members live in and around Lydney which means there is a diverse input of opinions and ideas.

It is our aim to improve the facilities, activities and address general issues within the Lydney area that concern young people. The Youth Council has 9 members currently, however we are looking for new participants between the ages of 11 - 18 as we hope to fill the 6 seats which are still available. So far our meetings have been hugely successful and we have recently designed our own logo so we will be recognisable to the public eye.

We are hoping our first target will

be reached within the next few months; our aim being to produce a seasonal leaflet of all the activities that are taking place, the pamphlet will be aimed at all ages. The second idea we hope to address is that of staging a 'Skate Jam' during the summer, to take place at Lydney Skate Park. Not only are we interested in introducing and hosting new events within Lydney Town, but our aim is to help and assist existing organisations and charities by volunteering where we are able. ### Why set up a Youth Council?

Young people are the future of our communities and it is important that we, as parish and town councils, invest in them. According to the Office of National Statistics, nearly a quarter of our national population is made up of people under the age of eighteen. They may not yet be able to vote yet but it is essential that these people are not ignored in our communities.

Fact: Article 12 of the UN Human Rights Convention states that young people, under the age of 18 have the legal right to formally express their opinions and for those opinions to be taken seriously. It places a legal responsibility on the decisionmakers to consult young people about the things that will affect them and recommends that this be done through establishing youth based groups such as youth councils as young people are finding themselves increasingly marginalised in their local communities.

Developing youth councils can act as a real means of incorporating young people into our communities and can lead to a more safer, vibrant and sustainable community for all residents.

# **Gateway Planting**

Improving our 'Gateways' is aimed at attracting additional tourism and reinstating a sense of pride in our local community. The Town Council have recently adopted a Lydney 'style' -Black & Gold, and you will see that the signage and the planters now match this corporate style Whilst planting has started in earnest, we were dismayed by the senseless theft of miniature conifers (weekend of 2&3rd March 2013) from the two planters on Cross Hands Junction and the one on Centurion Road - it needs to be recognised that these individuals are not stealing from the Town Council but are instead stealing from YOU! as all such initiatives are funded via the Precept/Council Budget and replacements increase these charges. 

## **Allotments**

Allotments provide a year round activity which is socially inclusive and reflects the ideals of sustainability and well-being, they also provide areas of green space in built up areas, often used by wildlife, thereby contributing to the protection of rare species and promoting biodiversity.

While 'allotment management' can be complex, and indeed places a very real obligation on local councils, currently in Lydney Town Council's case they remain an undervalued 'community asset' For the aforementioned reasons the Town Council have recently convened two public meetings in order to discuss the future use of Allotments in Lydney and to discuss the arrangements for that of an additional allotment site and those facilities that such a site should look to include.
