A reminder of what it's all about

Although deciding where new houses and industrial/retail units should be sited in our town, much of which has outline permission to the east of the town, is one important factor, the Neighbourhood Development Plan is about so much more.....

The NDP is about:

- 1. How new retail and employment opportunities must be encouraged, thereby supporting our town centre
- 2. Making sure residents and traders have an equal opportunity to 'shape' Lydney's future.
- 3. Improving Lydney's social, economic infrastructure and wellbeing for future generations
- 4. Ensuring that all future proposed planning applications meet the community's needs and that our 'open spaces' are protected and enhanced. That planning proposals are in accord with the NDP, existing governmental planning strategies and environmental policies.

An 'adopted' NDP provides the statutory right to challenge, to permit or to refuse a planning application.

Where are we?

We are drafting policies based on community and statutory consultee feedback, received during the public consultation period. We aim to complete the final draft of the Lydney Neighbourhood Plan by the end of March 2014.

LYDNEY'S VISION

It is fair when looking at Lydney, to also include the 6 hinterland parishes, which then bring the population up to 29,500 as Lydney services and provides facilities for such use.

Projections are difficult but Forest of Dean District Council figures suggest a further 400 new dwellings and 920 people in the next 5 years; and some 1,800 dwellings and 4,140 people in the next 10 to 12 years from the development to the east of Lydney.

"This is equivalent to building an additional settlement on the edge of Lydney half

the size of Coleford. Imagine the reaction if this was suggested for one of the Cotswold towns!"

There is a predicted sharp increase in older people 65+ years, some 70% on our base figure, and a small growth in 0-19 years. Add to these figures the expected increase in overall numbers in the groups having more need of health services and the problems are obvious.

Forest of Dean District Council's Lydney Area Action Plan (P.17., 4.35) "the core strategy depends on Lydney as the town with the greatest opportunity for change, and must provide a greater degree of self -containment"

"Our Forest our Future" (Forest of Dean Partnership) March 2008 reads, "Ensure access to high quality, sustained, locally provided health services which meet the health and well-being needs of the people living in the district"

In order to achieve such goals the adoption of Lydney's NDP is crucial.

The Forest of Dean Ramblers has an extensive programme of walks, many of which are in the Lydney & surrounding area. As well as local walks we have holiday trips in other areas such as the recent trip to Cumbria. We also undertake maintenance on Public Rights of Way. A recent project was the new bridge, walkway & steps at Upper Forge just north of Lydney. This extensive project was funded from the sale

of our book 'Exploring Historic Dean'. The man power was provided by the Ramblers, greatly assisted by the Dean Forest Railway & Gloucestershire County Council.

We are also consultees in planning applications which may have an effect on Public Rights of Way. This is an important aspect which ensures the continuing benefit to all of this important recreational resource. This is especially true to ensure that developers take due consideration to protect the footpath network.

With the continuing cut backs on funding by Gloucestershire County Council & likely privatisation of some of their functions, the maintenance work by the Ramblers is increasingly important. It is vitally important that we keep these valuable assets walkable for the enjoyment of future generations.

Flooding at Lakeside

On Christmas Eve, a blocked trash screen at the rear of 115 Lakeside Avenue, Lydney, resulted in seven properties being flooded in the area, six for the first time ever.

Timber, which had been felled many months earlier, the removal of which had been requested by residents on numerous occasions to avoid the impending disaster, was the cause.

Unfortunately, the Forest of Dean District Council (FODDC), who have powers in such matters, appear to have ignored the pleas of the residents, who through no fault of their own, now have to worry as to whether they will be able to get future insurance and will it be inflated, also will they be able to sell their properties.

Since the flooding it has also been established that in addition to the trash screen, the main culvert was 90% blocked. However, FODDC have now finally authorised the removal of any offending material which caused this man made disaster which should never have happened.

Discussions with FODDC are still ongoing and subsequent meetings after the flooding appear to have established that land/riparian ownership is a major important issue in taking matters forward. Another issue still in discussion are the broken fences, allowing children and adults to enter the site for the disposal of litter and fly-tipping to take place, which in turn enhances the blocking of the watercourse and the trash screen/culvert.

This latest incident has, unfortunately, brought a further stigma to Lakeside Avenue, which is already renowned for its past flooding issues.

The residents are appreciative of the part played by the Officers and Councillors of Lydney Town Council for their unblocking of the watercourse in the first instance, the issue of sandbags and for its on-going assistance, advice and shared concern.

Update on the Stream Culvert

After all the rain and since FODDC have unblocked the culvert, the stream level is now very low and running free and fast. There is however a couple of pieces of concrete still in the culvert probably caused by the base of the trash screen which is breaking up, this has the poten-

tial to cause further blockages at a later date if left unchecked or not removed.

FODDC have been asked to survey the whole length of culverts (main and divert) as there may be blockages further down, and I believe this is now in hand.

LYDNEY'S COUNTY COUNCILLOR REPORT

It has been a busy start to the year; below is just a sample of issues which are receiving my attention:

Wild Boar: I have been seeking to obtain a definitive opinion on the responsibility for managing the wild boar in the forest. DEFRA have advised that the primary responsibility for feral wild boar management lies with communities and individual land owners. The Forestry Commission does not need a mandate from anyone, as a responsible land owner it listens to views from all interested parties, including those of wildlife management. DEFRA have no plans to hold or fund a referendum on the management of wild boar.

A Unitary Authority: Gloucestershire County Council formed a Unitary Authority working group to investigate the possibility of adopting a unitary system, which would result in the cessation of District Authorities. However, as only one District Council positively co-operated with the investigation the working party has been deferred for the time being.

Further savings at Gloucestershire County Council: The County Council has to save a further £25 million a year until at least 2017/18. Shortly the five Group Leaders will begin a process which will (hopefully) lead to a saving of £75 million whilst still meeting the real need of the people of the county. This in itself is going to be difficult to balance.

A48 Safety: At the beginning of March 2014 a Gloucestershire County Council Scrutiny Meeting will take place which will focus on safety issues on the A48 and the very real necessity to reduce accidents on the roads we all tend to use frequently.

Lydney Town Council: The Council's CEO has worked tirelessly to secure vehicle activated signage (VAS) for the town which will be implemented within the 20 mph zone. It is hoped that the VAS's will be operational shortly after beginning of April 2014.


