PLANNING AND HIGHWAY COMMITTEE MEETING - 2018/09/10 - 11

MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 10 September 2018 at 5.59 pm.

PRESENT:

Due to the absence of Cllr Preest it was unanimously agreed that Cllr Harris would assume the position of Chairman until a Vice Chairman had been appointed.

Cllr Harris informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

#### 1. ELECTION OF VICE CHAIRMAN

**Cllr Greening proposed** Cllr Pearman for the position of Vice Chairman. **Seconded** by Cllr Harris. All agreed.

Cllr Harris resigned the position of Chairman at this point and Cllr Pearman assumed the role.

#### 2. APOLOGIES

Apologies for absence were received and noted from Cllrs Berryman, Christodoulides and Preest (late arrival)

#### 3. **DECLARATIONS OF INTEREST**

None.

#### 4. MINUTES OF PREVIOUS MEETING

Approval of the minutes of the Planning and Highway Committee meeting held on 9 July 2018 was **proposed by Cllr Ives, seconded by Cllr Harris.** Vote carried.

Notes from the Delegated Powers meetings held on 30 July and 21 August 2018 (Appendix A) were duly noted.

#### 8. USE OF WEEDKILLER

Prior to the meeting Members were provided with a copy of a letter of complaint which had been received from a member of the public in which they highlighted the recent legal challenge which had been successfully argued in the United States of America attributed to the use of glyphosate weedkiller. Members were also provided with a copy of the responses which had been obtained from the Council's supplier and UK Government Guidance in relation to the use of such products. Members were asked to consider if they wished to continue to use such products.

It was **proposed by Cllr Greening** that the Council would continue to use such products and would follow World Health Organisation guidelines. Cllr Greenwood advised that he had been contacted by the member of public who had provided examples of Towns which did not use weedkillers and he suggested that the matter be deferred until such time as he had time to research an alternative product. However, Members were reminded that a Motion had already been received which required consideration.

**Cllr Harris agreed to second** Cllr Greening's Motion which was then put to the vote. Vote carried.

Responding to a question raised by Cllr Leach, the CEO reminded Members of the Six Month Ruling.

#### 9. PARKING

Cllr Greening expressed concern that emergency vehicles may be prevented from accessing some areas due to the number of vehicles/inconsiderate parking which was evident throughout the Town. Cllr Greening highlighted that the section of carriageway from Pylers Lane to Rodley Road was particularly troublesome as those with pushchairs/wheelchairs had to use the middle of the road due to vehicles obstructing the width of the pavements. Cllr Greening questioned if double yellow lines could be installed on one side of the carriageway so as to afford vehicular access for emergency vehicles.

During discussion Members noted that the situation described by Cllr Greening was not unique to Lydney and was a direct result of an increased number of vehicles on the road which could not be catered for by traditional parking arrangements. Cllr Harris advised that she had previously discussed the possibility of creating a one-way system for Klondyke and Steel Avenue with Mr B Watkins, Gloucestershire County Council, but the matter had not been progressed. It was noted that vehicles were parking on verges in residential areas (e.g. Jubilee Road) and that vehicles were being parked on a grassed area in Rodley Road.

Responding to the question which had been raised regarding the provision of double yellow lines Cllr Ives advised that a statutory process would need to be observed by Gloucestershire County Council and that if objections were received from residents the

process would fail. Furthermore, statutory evidence would need to be provided that a safety issue existed.

Cllr Preest arrived at this point.

A Point of Order was called at this point due to the Committee Chairman being in attendance but not actually Chairing the meeting. Cllr Preest Chaired the meeting from this point.

#### 10. LYDNEY CYCLE IMPROVEMENT SCHEME

Prior to the meeting Members were provided with details of the proposed plans which had been on display as part of the Public Event hosted by Gloucestershire County Council (GCC) on 4 September 2018. Members were also provided with details of the Public Event in advance in order that they may take the opportunity to familiarise themselves with the proposals and speak to GCC Officers directly.

Cllr Preest provided an overview of how LEP funding for the proposals had been secured. Members' attention was drawn to the fact that the proposals included the utilisation of areas of land within the ownership of Lydney Recreation Trust and it was noted that the proposed scheme should therefore be an agenda item for the next Trust meeting.

During discussion a number of comments were made about the proposed scheme (e.g. need to consider increased street lighting in certain areas, the potential removal of the right turn lane into Tutnalls Street, responsibility for verges either side of FLY24, etc) and it was agreed that such comments would be forwarded to GCC in order that they may clarify such points. The proposed Parkend to Lydney cycle route was touched on, however, Members were informed that such was a completely separate project to the routes which would be funded via the LEP funding. After a short further discussion it was **proposed by Cllr Harris**, **seconded by Cllr Greening**, that the proposed cycle improvement scheme would be an agenda item for Lydney Recreation Trust in order that its comments may be recorded and the Officer at GCC notified prior to the target date. Unanimous.

#### 13. COMMUNITY RIGHT TO BID

Members were asked to consider if there were any other premises which they wished to register. After a short discussion it was **proposed by Cllr Ives**, **seconded by Cllr Harris**, that the Council would seek to register the Baptist Chapel in High Street.

During discussion Cllr Preest expressed concern that contradicting information had been given by the Local Planning Authority regarding the ability for local sporting clubs to apply for S106 contributions and it was agreed that the matter would be discussed further at the Delegated Powers meeting.
