MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 8 October 2018 at 5.58 pm.

Cllr Preest informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

Apologies for absence were received and noted from Cllr Berryman.

6. TEMPORARY ROAD/FOOTPATH CLOSURES, CREATIONS/DIVERSIONS

Cllr Preest reminded Members that Driffield Road would be closed at its junction with Highfield Lane to Tree Tops Driveway from 8 October 2018 to 10 December 2018

7. HIGHWAY CORRESPONDENCE

- Members were informed that the Council had been offered a "free trial" of a new mobile CCTV system by Redhand, once the system had been tested and was made available. It was noted that the system would be fully portable and could therefore be sited in numerous locations throughout the Town and Members were advised that provision had been included in the 2019/2020 draft budget towards the cost of purchasing such a system/additional cameras.
- Gloucestershire County Council Notification from Mr G Wheeler, Public Rights of Way Officer, that he had added the need to address the tree root which is pushing up the footpath on FLY24 (just down from the Tennis Club) to his list of programmed works. Mr Wheeler will advise the Town Council nearer the time when the work will be conducted.

13. S106 DEVELOPER CONTRIBUTIONS LISTING

Members were informed that the Council's "wish list" had been submitted to the Local Planning Authority in respect of an application by Robert Hitchins Limited.

During discussion the CEO explained that the Local Planning Authority had now clarified the procedure which was followed when considering S106 contribution requests, namely:-

The Town Council/interested organisations should approach the Planning Officer allocated to a particular application if they feel that it may attract a S106

agreement to establish if the Council's/organisations "wish list" should be considered for a relevant application.

- The Planning Officer will then consider any "wish lists" received and decide if contributions should be included as part of the S106 Agreement for the site, should planning consent be approved.
- Once the S106 Agreement is signed it is then passed to the Appeals Technician to deal with requests for drawing down monies which have been agreed.

It was noted that the Planning Officer allocated to the application from Robert Hitchins Limited had advised that "wish lists" had been received from the Town Council, Lydney Tennis Club, the Bathurst Park and Recreation Trust, Lydney Cricket Club and Lydney Town Hall. The CEO advised that it would appear "wish lists" had not been submitted by Bathurst Pool, Lydney Town AFC or Lydney Rugby Club, however, she had advised the aforementioned organisations of the need to submit their "wish lists" to the Planning Officer as soon as possible.

14. **COMMITTEE BUDGET 2019-2020**

Members were provided with a copy of the draft Committee Budget for 2019-2020 for their consideration. It was noted that contributions had been included towards the cost of providing increased CCTV provision/a mobile CCTV system for the Town and the provision of a security presence (including a dog unit) for Bathurst Park and Lydney Recreation Ground for two days per week. It was noted that whilst funding for such deterrents had been included in the draft budget, the Committee would be required to debate the implementation of such at a future meeting.

After taking an opportunity to peruse the draft budget it was **proposed by Cllr Harris**, **seconded by Cllr Pearman**, that the Committee would approve a budget for 2019-2020 of £18,950.00. Unanimous.

15. COUNCILLORS REPORTS

Cllr Harris reported that large vehicles were once again attempting to access JD Norman via Tutnalls Street. It was noted that large signs advertising the access route for JD Norman had been erected at the Town entrances on the A48; that JD Norman had been given a unique postcode by the Post Office which was not linked/associated with Tutnalls Street and that most of the difficulties experienced related to use of Satnavs.

Cllr Harris requested an agenda item for the next meeting regarding the provision of a bus shelter at the Allaston Road/Court Road junction.

Action by – the CEO

Cllr Christodoulides expressed concern over the number of trip hazards evident at Lydney Harbour (e.g. chains over grass, lack of water in Harbour basin, etc). It was agreed that the CEO would bring the matter to the attention of the Environment Agency.

Action by - the CEO

Cllr Greenwood expressed concern over the condition of the highway at The Villows. Cllr Preest advised that Gloucestershire County Council were currently focused on

resurfacing large stretches of highway, however, he gave a commitment to raise the condition of the highway in this area again.

Cllr Preest advised that Gloucestershire County Council's Lengthsman Scheme would be operational in the Parish w/c 15 October 2018.

Cllr Leach reported that a number of trees were overhanging the pavement in Grove Road and gave a commitment to contact the landowner to request that they be cut back.
