MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 14 April 2014 at 7.02 pm.

Cllr Bevan informed all present that no practice fire evacuation had been scheduled for the duration of the meeting. All attendees were then informed of the locations of the nearest fire exits.

1. APOLOGIES

No apologies for absence were received.

2. **DECLARATIONS OF INTEREST**

It was noted that one of the planning applications to be considered had been submitted by the Town Council, accordingly, the Council would refrain from commenting on the application.

3. MINUTES OF PREVIOUS MEETING

Approval of the minutes of the Planning and Highways Committee meeting held on 10 March 2014 was **proposed by Cllr Berryman**. **Cllr Harris agreed to second** subject to an amendment to reflect that she had also advised of locations where mobile CCTV units remained positioned. Vote carried.

4. **OPEN FORUM**

Mr W Owen, 3 Augustus Way, Lydney – highlighted the condition of Highfield Road and the development near the bottom of Highfield Road, which he felt resulted in vehicles choosing to divert via Kimberley Drive. County Cllr Preest advised that Mr B Watkins, Gloucestershire County Council had confirmed that the road surface in the area had previously been patched but this had now come undone. Discussion then took place over the development near the bottom of Highfield Road and County Cllr Preest advised that he awaited a response from Mr Watkins regarding the reinstatement of the area, furthermore, that he had been advised by Mr Watkins that the signage that they had ordered for Tutnalls was too large to erect (no HGV access to J D Norman") on the current sign.

7. <u>HIGHWAY CORRESPONDENCE</u>

Kimberley Drive/Church Road

Prior to the meeting Members were provided with a copy of the response received from Mr B Watkins, Gloucestershire Highways, regarding the possibility of traffic calming measures in Kimberley Drive and the removal of the chicane by Lydney War Memorial in Church Road. Cllr Preest requested that Mr Watkins be invited to attend the June Committee meeting.

Lydney Air Quality Meeting

Prior to the meeting Members were provided with a copy of the response from Mr C Ball, Forest of Dean District Council, in which the Town Council's request for a presentation was deferred until later in the year. County Cllr Preest advised that he had requested that the Leader of Gloucestershire County Council expedite the matter, due to the problems experienced at the Bream Road junction.

Gloucestershire County Council

Prior to the meeting Members were provided with a copy of the letter which had been received from County Cllr V Smith, Cabinet Member for Highways & Floods, advising that the County's Highway contract with Skanska would end on 31 March 2014 and that the new service provider, Amey, would commence on 1 April 2014. It was noted that the current 08000 514514 problem reporting number would remain, and that highway issues could also be e-mailed to gccHighways@amey.co.uk. Furthermore, that the existing Area Highway representatives and Public Rights of Way Officers would transfer to Amey.

Cllr Bevan urged all Councillors to report highway issues directly to Gloucestershire County Council via the above methods and County Cllr Preest suggested that Members allow the new organisation a few months to "bed in" and confirmed that he would progress any unresolved issues after this period.

8. PLANNING APPLICATIONS

P0346/14/FUL - Ms M Challener, 18 Victoria Road, Lydney

Alterations and erection of a single storey rear extension to provide an office, utility, bathroom and 2 additional bedrooms. Demolition of existing utility (single storey extension).

Council notes that an adjacent neighbour has not been consulted on the application. Furthermore, Council requests that a site visit be conducted due to concerns over access and car parking issues. Council also feel that the development, given its location, may impact on the nearby conservation area.

Whilst the Council does not object to the application, it notes that the development is located on a flood plain and therefore wishes to be provided with an assurance that the provision of a 1m wide concrete spectator path will not have an adverse, detrimental effect. Furthermore, Council request the inclusion of a Planning Condition requiring the applicant to re-instate the land to its original condition (removal of hardcore/concrete, etc) should it relinquish its lease of the site.

10. PLANNING CORRESPONDENCE

- E-mail from Mr C Reynolds, Development Manager, Forest of Dean District Council re update to National Planning Practice Guidance. **Noted**.
- Letter from Mr F Russell, Senior Environmental Protection and Licensing Officer, re application by Harrys Bar, Newerne Street, Lydney. Response noted that the applicant was applying to extend their opening time by 30 minutes and that the Police had supported the applicant's request.

11. OAKDALE DEVELOPMENT

Prior to the meeting Members were provided with copies of the correspondence between the CEO and the Health and Safety Executive (HSE), and Mr D Street and the HSE regarding numerous issues on the development. The CEO sought guidance from the Committee regarding the direction which they now wished to take as it appeared that the HSE felt that the issues on site had been addressed by the developer. It was noted that Forest of Dean District Council had previously served Enforcement Notices on the developer and that provided the developer had commenced work on the issues, they were deemed to be complying with the Notice.

During discussion Mr Street reported that whilst the developer had installed a number of columns on the site, they had negated to install lights atop of said columns. Furthermore, a number of Herras fencing panels had fallen over and were felt to be trip hazards and that parents had resulted to pushing prams in the road, rather than use the poor pavements which had been provided. It was suggested by Cllr Preest that he, together with Mr Street and Cllr Bevan meet on site to identify the issues faced by residents, in order that they may be reported to the HSE on the appropriate form. Cllr Preest extended an invitation to his fellow Councillors to also attend the meeting.
