Contribution from Aylburton Parish Council

Cllr Berryman declared an interest in this matter and did not participate in the discussion.

Members were then asked to consider the contribution to be requested from Aylburton Parish Council towards the cost of maintaining the Cemetery. It was **proposed by Cllr Harris**, **seconded by Cllr Ives** that the sum of £231.00 would be requested in respect of the 2016-2017 financial year. Unanimous.

7. **BURIAL POLICY**

Prior to the meeting Members were provided with a copy of the current Cemetery Rules and Regulations.

Cllr Ives drew attention to the current restrictions which prevented members of the public from being interred in the Cemetery if they had moved out of the Parish for over 12 months

(unless they had lived in the Parish for at least five years and, through no fault of their own, had moved out of the Parish to go to hospital, or to live in a residential care establishment or nursing home, or into family care, on a permanent basis). Cllr Ives called for his fellow Councillors to consider increasing the length of time a member of the public may live outside of the Parish and still be permitted to be interred in Lydney Cemetery following their death.

Extensive discussion took place on the benefits which could be afforded to reviewing the Council's regulations in this respect and consideration was given towards replacing the current restriction with one which permitted residents with a strong link to the Town to be interred in the Cemetery once they no longer resided in the Parish. However, the CEO sought clarification on the definition of a "strong link" the interpretation of which may be subjective and were reminded that Delegated Powers would need to be bestowed on an Officer in such instances in order that bereaved families may progress funeral arrangements.

After a short further discussion it was **proposed by Cllr Ives, seconded by Cllr Harris,** that members of the public who had moved out of the Parish for up to 36 months (unless they had lived in the Parish for at least five years and, through no fault of their own, had moved out of the Parish to go to hospital, or to live in a residential care establishment or nursing home, or into family care, on a permanent basis) would be permitted to be interred in Lydney Cemetery following their death. Vote carried.

8. ADDITIONAL BURIAL PROVISION

Cllr Berryman advised that no progress had been made with this matter.

9. **COUNCILLORS REPORTS**

No reports were made.
