Cllr Preest informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

No apologies for absence were received.

2. **DECLARATIONS OF INTEREST**

3. <u>MINUTES OF PREVIOUS MEETING</u>

Approval of the minutes of the Planning and Highway Committee meeting held on 12 October 2015 was proposed by Cllr Vaughan, seconded by Cllr Street. Unanimous.

4. **OPEN FORUM**

No requests to speak were received.

HIGHWAY, FOOTPATH AND TRANSPORT ISSUES

5. SIGNAGE

County Cllr Preest reported that the relocation of the Vehicle Activated Sign from Highfield Road to Bream Road was proving to be problematic due to Gloucestershire County Council's (GCC) decision to change contractors. County Cllr Preest gave a commitment to pursue the matter with GCC's Commissioning Director during their imminent meeting.

6. GATEWAY AND ROUNDABOUT SPONSORSHIP (RE. LYDNEY IN BLOOM)

The CEO advised that the floral gateway displays sponsored by Travis Perkins Trading Company Limited would be in situ from Spring 2016 and that a meeting would be arranged between the proposed sponsor of the Roundabouts, representatives from Gloucestershire County Council and Lydney Town Council in order to further the proposed improvements/design statements.

7. **GRIT BINS**

Members noted that in line with previous instruction four grit bins had been ordered and since positioned in agreed locations; Gloucestershire County Council had declined to include the grit bin for Oakdale on their replenishing route as the road had yet to be

adopted. County Cllr Preest gave a commitment to obtain a definitive guide from Gloucestershire County Council regarding the number of unadopted roads in the Town.

Members expressed their dissatisfaction with the response and County Cllr Preest gave a commitment to raise the matter with GCC's Commissioning Director at their imminent meeting.
