MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 8 February 2016 at 5.58 pm.

Cllr Preest informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

1. APOLOGIES

Apologies for absence were received and noted from Cllr Berryman.

2. **DECLARATIONS OF INTEREST**

None.

3. MINUTES OF PREVIOUS MEETING

Approval of the minutes of the Planning and Highway Committee meeting held on 11 January 2016 was proposed by Clir Street, seconded by Clir Pearman. Vote carried.

4. **OPEN FORUM**

HIGHWAY, FOOTPATH AND TRANSPORT ISSUES

5. **SIGNAGE**

County Cllr Preest reported that no update had been received from Mr B Watkins due to the change in Gloucestershire County Council's contractor and gave a commitment to progress the matter.

6. **JUNCTION ISSUES**

The Willows Junction

County Cllr Preest reported that he had been informed by Mr B Watkins, Gloucestershire County Council, said Authority had provided funding to Forest of Dean District Council to undertake drainage improvements including the provision of a new culvert to discharge water into the nearby watercourse, which was believed to be Plummers Brook. County Cllr Preest was not aware that any enforcement action would be taken against the landowner and he gave a commitment to obtain a timescale for implementation for the scheme from Forest of Dean District Council.

7. ROUNDABOUT SPONSORSHIP (RE, LIB)

The CEO advised that a positive meeting had taken place with the potential sponsor, Mr B Watkins (Gloucestershire County Council) and representatives from Lydney Town Council, during which the requirements to ensure that any improvements were "passively safe" was accepted by all parties. Furthermore, it was acknowledged that the proposed schemes formed part of a wider drive to bring improvements to the Town

whilst forging links with industries which had historically been carried out in the Parish. Mr Watkins had agreed to work with the potential sponsor in order to ensure that the designs complied with highway requirements prior to the submission of a formal planning application.

8. TEMPORARY ROAD/FOOTPATH CLOSURES, CREATIONS/DIVERSIONS
Members noted the response received from Gloucestershire County Council as to why
pedestrian/emergency access could not be maintained during the Full Road Closure from
the Fairtide Centre to the junction with the A48 from 28 February 2016 to 28 March
2016 (no properties requiring access/unsafe for pedestrians to pass on narrow road).

Temporary Road Closure - Driffield Road 9-12 February 2016. Noted.

9. HIGHWAY CORRESPONDENCE

Order confirmation received re. Highfield Road, Lydney – U Turn & Toucan crossing. Noted.

PLANNING ISSUES

10. OAKDALE

Cllr Vaughan reported that she had attended a Forest of Dean District Council Planning Committee Sites Inspection relating to the application by MMC for Phase 2 and provided members with an overview of the concerns which had been raised (e.g. inadequate footpaths, increase traffic, increased housing opposite Boating Lake Lane, isolation of residents, etc). Members noted that the Admin Assistant was progressing the provision of a post box for Oakdale with Royal Mail; that Cllr Vaughan was liaising with Bromford Housing regarding the creation of a Facebook page for residents as well as the provision of street signage.

All Members were informed that Cllr Vaughan would be meeting with a representative from Base Estates in the near future and were asked to inform Cllr Vaughan of any issues relating to maintenance of the development.

The CEO advised that a further meeting of the Oakdale Stakeholder Group would take place as soon as a date had been provided by Mr B Holmes.

11. FODDC ALLOCATIONS PLAN HEARING DATE

Cllr Pearman advised that on behalf of the Council he had attended two days at the Allocations Hearing date and provided a précis of the discussions which had taken place.

Concern was expressed that if the Forest of Dean District Council's Allocations Plan was not passed by the Inspector, it would result in a large number of planning applications being submitted throughout the district. The importance of the NDP referendum was explained to Members, together with the need to ensure its adoption.

12. FODDC PLANNING REVIEW

Cllr Preest expressed disappointment that Forest of Dean District Council had yet to formally write to Parish and Town Councils to inform them of the Peer Challenge which was being undertaken on Planning Services.

13. PLANNING APPLICATIONS

P1881/15/FUL – MMC Land and Regeneration, Land East of Par Four Lane, Lydney Erection of 347 residential units, access and highways, open space, landscaping and associated infrastructure comprising phase 2 "Higher Lydney Park"

Objection. Based on the information contained in the planning application Lydney Town Council are extremely concerned with the proposed drainage for the development and the effect the proposed scheme will have on the neighbouring watercourse/existing properties in Lakeside Avenue. Lydney Town Council has, on numerous occasions, reiterated the importance of ensuring no such water should be allowed to enter existing watercourses. The Local Planning Authority is already aware of the detrimental effect that water runoff from surrounding land has on Lakeside Avenue; any new development must reduce, not exacerbate, the level of run off currently experienced.

Lydney Town Council notes the objections raised by the Lead Local Flood Authority regarding the proposed drainage for the site and strongly supports their objections which must be addressed prior to consent being given.
