PLANNING AND HIGHWAY COMMITTEE MEETING - 2016/03/14 - 41

MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 14 March 2016 at 6.10 pm.

Cllr Pearman informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

Cllr Pearman chaired the meeting until Cllr Preest's arrival at 6.44 pm.

Prior to the commencement of the meeting, Cllr Pearman welcomed three representatives from Redrow. Members were informed of Redrow's plans to develop a section, comprising 125 dwellings and an area of public open space, of the Robert Hitchins Limited site off Highfield Road. It was noted that building would commence shortly after Robert Hitchins Limited had commenced installation of the associated infrastructure. Members were provided with copies of a draft site layout and design plan for their perusal.

During discussion it was noted that Redrow intended to appoint a Management Company to maintain the public open space. Members highlighted their desire that water from the development was not directed towards the existing watercourses and that problems were already being experienced on recent housing developments where attenuation ponds were utilised, due to clay soil in the area. Attention was also drawn to the DEFRA recommendation that Public Rights of Way were not diverted onto public highways. Whilst is was acknowledged that the diversion of the Public Right of Way (FLY36) was a matter for Robert Hitchins Limited, representatives from Redrow gave a commitment to raise the matter with said organisation.

Cllr Pearman thanked the representatives from Redrow for attending the meeting and they then left the meeting at 6.20 pm.

10. OAKDALE

Members expressed their frustration with the lack of progress which had been made with arranging at Stakeholders meeting, the installation of signage and also the rectification of street lighting issues on the site.

Cllr Pearman gave a commitment to contact Mr Holmes, MMC, yet again in an attempt to arrange a meeting.

11. FODDC PLANNING REVIEW

Cllr Pearman advised that he had attended the Peer Review meeting at Forest of Dean District Council on behalf of the Council and provided Members with an overview of the meeting. Members were disappointed to note that only six Parish/Town Councils had been represented and Cllr Pearman believed that the findings of the Review would be made public shortly.

12. BREEDON AGGREGATES

Prior to the meeting Members were provided with a copy of an e-mail which had been received from Newland Parish Council in which they requested that Lydney Town Council, due to the effect that the application (15/0108/FDMAJM) would have on the Town, consider earmarking £1,000 towards an opposition campaign organised by Newland and St Briavels Parish Councils.

Cllr Greenwood requested that consideration of the matter be deferred until the arrival of Cllr Preest (who arrived at 6.44 pm). Members then considered planning applications which had been received, however, the minutes reflect the order as shown on the agenda.

Cllr Preest declared an interest in this matter due to his appointment to Gloucestershire County Council's Planning Committee.

During discussion concern was expressed over the increase in traffic along Bream Road which would be experienced as a result of the application by Breedon Aggregates. Members also highlighted the adverse effect that the increase in traffic would have on the Lydney Air Quality Management Area and the notorious bottleneck known as the Bream Road junction. Furthermore, Members recalled the safety issues for Schoolchildren which had been experienced with increased traffic/inconsiderate parking in Bream Road and the length of time it had taken to resolve the situation through the provision of double yellow lines. Cllr Preest requested that the CEO contact Forest of Dean District Council to obtain a copy of the report which had been undertaken in 2014 regarding air quality and possible improvements for Bream Road junction.

Action by - the CEO

Whilst it was noted that the Council had not been consulted on the application in its capacity of Statutory Consultee and that the deadline for receipt of comments had expired, it was **proposed by Cllr Greenwood**, **seconded by Cllr Street**, that the Council's material considerations would be submitted to the Case Officer at Gloucestershire County Council and that should the application be granted consent, a suitable condition should be placed on the development to financially contribute towards improvements in Bream Road due to the effect on the Lydney Air Quality Management Area.

Action by - the CEO

Attention was then turned to the request by Newland Parish Council to earmark £1,000 towards an opposition campaign. After due consideration, it was **proposed by Cllr Preest, seconded by Cllr Greenwood,** that the request would be placed in abeyance, pending receipt of the Lydney Air Quality Management Report from Forest of Dean District Council.
