MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 12 October 2015 at 6.00 pm.

Cllr Preest informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

### 1. APOLOGIES

Apologies for absence were received from Cllr Street.

# 2. <u>DECLARATIONS OF INTEREST</u>

None.

## 3. MINUTES OF PREVIOUS MEETING

Approval of the minutes of the Planning and Highway Committee meeting held on 14 September 2015 was proposed by Cllr Pugh, seconded by Cllr Vaughan. Unanimous.

Prior to the meeting Members were provided with a copy of the notes from the Delegated Powers meetings held on 21 September 2015. Noted.

#### 4. **OPEN FORUM**

No members of the public in attendance.

#### 5. **BUDGET 2016/2017**

Members were provided with a copy of the draft budgets which had been produced for 2016/2017 Financial Year for the Planning and Highway Committee and also for the Lydney Neighbourhood Development Plan (NDP). Members were informed that the "corporate" element of the NDP budget for 2016/2017 had already been approved by the Personnel Committee.

After taking an opportunity to consider the draft budgets the following was proposed:

Planning and Highway Committee budget – 2016/2017 – it was proposed by Cllr Pugh, seconded by Cllr Vaughan, that the proposed budget of £5,250 would be approved. Unanimous.

NDP budget – 2016/2017 – it was **proposed by Cllr Berryman, seconded by Cllr Openshaw,** that the non-corporate proposed budget of £3,250 would be approved and that with the Corporate NDP element that the NDP budget equated to £16,005. Unanimous.

#### **HIGHWAY, FOOTPATH AND TRANSPORT ISSUES**

### 6. SIGNAGE

County Cllr Preest reported that on 5 October 2015 he and the CEO had been advised by Mr B Watkins, Gloucestershire County Council that the relocation of the Vehicle Activated Sign from Highfield Road to Bream Road would be imminent. County Cllr Preest gave a commitment to continue to progress the matter.

#### 7. ROUNDABOUT SPONSORSHIP (RE. LIB)

Members were informed that discussions were still on-going with Mr B Watkins, Gloucestershire County Council, regarding the proposed improvements to the roundabout. The CEO advised that Travis Perkins Trading Company Limited had agreed to sponsor the Gateway signage and provide an annual donation of £1,000 towards the planting cost of same. Travis Perkins Trading Company Limited had also indicated that they were still interested in sponsoring the roundabout, should the other organisation withdraw their interest.

## 8. GCC LENGTHSMAN SCHEME

County Cllr Preest advised that the Lengthsman Scheme trial had now concluded at Lydney and was now being trialled in other areas. Members were informed that once the scheme had been trialled in a number of areas a report on the benefits of the scheme would be considered by Gloucestershire County Council's cabinet and County Cllr Preest gave a commitment to lobby for the continuation of the scheme, albeit with greater liaison being carried out with the CEO.

### 9. GRIT BINS

Members noted that grit bins for Lynwood Road and the junction of Bream Road/Grove Road have been ordered and delivery was awaited. Furthermore, that Mr B Watkins, Gloucestershire County Council had been asked to confirm that the aforementioned grit bins had been included on the County Council's replenishing list.

Members were then asked to consider requests for grit bins which had been received for the following locations:

- Entrance to Par Four Lane, Oakdale
- Sharp right hand bend on Springfield Road/Primrose Hill
- Replacement bin for Stanford Road/Grove Road
- Junction by 21 or 7 Woodland Rise

It was proposed by Cllr Greenwood, seconded by Cllr Pearman that grit bins would be purchased for the above locations at a cost of £78.25 each plus VAT and £40.00 delivery in addition to a sticker for each bin at £8.00 each plus VAT. Unanimous.

After a short discussion Cllr Christodoulides requested that the CEO enquire if it would be possible for Gloucestershire County Council gritting lorries to grit the incline in Tutnalls Street when they grit the roads.

#### 10. **JUNCTION ISSUES**

#### **Kimberley Road Junction**

County Cllr Preest advised that signage had been erected in the area and that monitoring of the area would continue and advised that Mr B Watkins, Gloucestershire County Council felt speeding to be a problem throughout the Forest. Noting that the Community Safety Partnership provided use of mobile speed cameras for use by the Community, Cllr Pearman suggested that the Council may wish to investigate utilising said facility. Council Cllr Preest advised that this option was already being investigated; that he had received a written complaint regarding speeding which would be handed to the local Police.

#### The Willows Junction

County Cllr Preest reported that Mr B Watkins had advised that the matter had been passed to the Enforcement Team to address. However, Cllr Greenwood felt that the issue stemmed from the fact that the drains beneath the roadway were not taking the waste water away from the junction as he believed that they were blocked. County Cllr Preest agreed to clarify the action which would be taken by Mr Watkins.

#### **Orchard Road/Tutnalls Street Junction**

Members noted that an e-mail had been sent to the Police regarding inconsiderate parking at the junction, to which a response was awaited.

#### 13. OAKDALE

#### **Provision of Rumble Strips**

After seeking advice from Mr B Watkins, Gloucestershire County Council, Cllr Pearman advised that Gloucestershire County Council were reluctant to install rumble strips on the A48 approach to the roundabout as they feared that it would lead to noise complaints from residents who lived adjacent to the approach.

It was felt that numerous signage had been erected on the approach advising of the roundabout and that the accidents which had occurred were believed to be through lack of attention by drivers.


