MINUTES OF THE PLANNING AND HIGHWAY COMMITTEE MEETING held in the Council Chamber, Claremont House, Lydney on Monday 9 December 2019 at 6.04 pm.

1. APPOINTMENT OF VICE-CHAIR

Cllr Leach proposed Cllr L Arnold for the position. Seconded by Cllr J Greenwood. There being no other nominations the proposal was put to a vote. Unanimous.

Due to the absence of Cllr Preest, Cllr L Arnold chaired the meeting from this point. Cllr L Arnold informed all present that no practice fire evacuation had been scheduled for the duration of the meeting.

4. MINUTES OF PREVIOUS MEETING

Approval of the minutes of the Planning and Highway Committee meeting held on 11 November 2019 was **proposed by Cllr Greenwood**, **seconded by Cllr Leach**. Unanimous.

5. **OPEN FORUM**

Cllr R Holmes – Questioned if any action had been taken regarding writing to businesses in the vicinity of the Newerne Street/Albert Street junction to request that they ensure that any deliveries are made to the rear of their premises in order to minimise any disruption to the traffic flow. The Clerk confirmed that whilst contact had been made with the Local Highway Manager for Gloucestershire County Council regarding the issue, no contact had yet been made with local businesses and he gave a commitment to progress the matter.

7. HIGHWAY CORRESPONDENCE

Town Meeting, however, it was felt that Members would need to initially meet with
an Officer from the organisation. It was agreed that an invitation would be extended
to attend the January meeting.

Letter re A48 safety – Prior to the meeting Members were provided with a copy of a
letter which had been received from a member of the public suggesting a number of
highway improvements which could be made to the A48 and the A40 at Over.
Members requested that the letter be referred to Gloucestershire County Council
who were responsible for the public highway.

Street Names

Members were asked to re-consider the suggestion by Cllr Leach which had been noted at the June Committee meeting, namely that the Committee may wish to consider utilising groups of names from the following:

- ❖ A Town or District that Lydney may have an association with
- Well known forest landmarks
- A group of streets named after landmarks in another city to create a region
- As previous, but utilising international cities/towns
- Utilising a group of names of fictional characters e.g. TV detectives

During discussion it was suggested that an approach could be made to Brehal (the French town twinned with Lydney) to ascertain if they would like to suggest any names. Members also felt that a post could be placed on the Town Council's Facebook page inviting suggestions from members of the public. Cllr L Arnold suggested that the Council may also wish to consider utilising the names of Councillors who had served the Council but had sadly passed away in recent years.

8. SECTION 106 AGREEMENTS

Prior to the meeting Members were provided with a copy of a breakdown of S106 agreement contributions and trigger points which related to Lydney for their information. The Clerk advised that the list covered the period to September and gave a commitment to contact Forest of Dean District Council to request the list be updated to reflect November's figures. Mr D Kent recommended that contact be made with Mr Stephen Colegate, the Planning Officer monitoring S106 agreements.

9. BT TELEPHONE KIOSKS

Members were provided with copies of the proposal from BT to remove three kiosks in Lydney, together with the ability to adopt any red "heritage" telephone boxes which the proposal may be seeking to remove for the sum of £1.00.

During discussion Members spoke in support of retaining the kiosk at the Co-op and the railway station as they noted the high value and regular use of these facilities. However, Members felt that the kiosk at the railway station could benefit from attention to increase its visibility (e.g. cutting back the surrounding vegetation, etc).

It was **proposed by Cllr Z Arnold, seconded by Cllr L Arnold,** that the Committee would object to the proposed removal of the telephone kiosks at the Co-Op and the railway station and would register an interest in adopting the kiosk at Lydney Industrial Estate, Harbour Road. Unanimous.



13. PLANNING CORRESPONDENCE

14. COUNCILLORS REPORTS

Cllr Leach advised that whilst action had been taken by Gloucestershire County Council to address a noisy manhole cover in Bream Road, he felt that motorist were now taking greater evasive action as they felt that the manhole cover was sinking as it had only been partially covered in tarmac. Cllr Leach requested that the issue be reported to Gloucestershire County Council and it was agreed to make this an agenda item for the next meeting.

Cllr Greenwood requested that Members receive an update on the Lydney Cycleway. Whilst he noted that both positive and negative comments had been received, Cllr Greenwood felt that the disruption which had been caused was the main cause of irritation for members of the public. During discussion concern was voiced over the narrowing of the carriageway in Hams Road; reports that buses had struck cars when attempting to access the Bus Station; the poor condition that pavements had been left in which Members believed posed a safety issue for elderly/vulnerable members of the public. It was agreed that the Clerk would contact the Public Liaison Officer for Griffiths, the contractor engaged by Gloucestershire County Council to implement the scheme, to relay the Committee's concerns and seek an update on the scheme.

15. **2020-21 DRAFT BUDGET**

Members were provided with a copy of the draft budget for 2020-21. The Clerk drew attention to the fact that the proposed budget had reduced as it did not include any provision for additional CCTV for the Town as no new equipment had been purchased in 2019. It was suggested that any unspent sum in this budgetary heading could be allocated to Earmarked Reserves at the end of the financial year in case additional equipment was required in the future.
