Cllr Preest informed all present that no practice fire evacuation had been scheduled for the duration of the meeting. All attendees were then informed of the locations of the nearest fire exits.

1. **ELECTION OF VICE CHAIR**

It was **proposed by Cllr Vaughan, seconded by Cllr Christodoulides,** that Cllr B Pearman be elected to the position. There being no other no other nominations Cllr Pearman's nomination was put to a vote. Unanimous.

2. APOLOGIES

Apologies for absence were received and noted from Cllrs Berryman and Greenwood

Cllr Openshaw arrived at this point.

3. **DECLARATIONS OF INTEREST**

4. MINUTES OF PREVIOUS MEETING

Approval of the minutes of the Planning and Highways Committee meeting held on 8 June 2015 were **proposed by Cllr Pearman, seconded by Cllr Street,** subject to a correction that the reference to FLY/87 against P0278/15/FUL should have been allocated to the application relating to Crump Farm. Unanimous.

5. **OPEN FORUM**

Mr W Owen, 3 Augustus Way, Lydney – Relating to agenda item 5, Mr Owen felt that items brought forward under the Open Forum should not need to be only those listed on the Agenda. A Point of Order was called by Cllr Preest who reminded all present that the format of the Open Forum had been agreed by Full Council as part of its Standing Orders and Mr Owen was advised that he could write to the Council if he wished to raise any issue which was not an agenda item.

6. SIGNAGE

Federal Mogul/JD Norman signage

County Cllr Preest stated that he, together with Cllr Pearman and the CEO had recently met with Mr B Watkins, Gloucestershire County Council, and advised that signage

would be located on both the junction at Cross Hands and the Lydney/Aylburton Roundabout advising of the correct route to be taken to access JD Norman.

During discussion concern was expressed as lorries were still attempting to access JD Norman from Hams Road/Tutnalls Street despite the aforementioned signs already been in situ. It was felt that the only option to fully resolve the issue would be if J D Norman were to be provided with a unique postcode. It was **proposed by Cllr Pearman**, **seconded by Cllr Preest**, that the CEO would contact the Local Planning Authority to explain the issues which were being experienced and to ascertain if they would be willing to raise the matter with Royal Mail. Unanimous.

Lydney In Bloom

Due to the requirement to obtain formal planning consent for the sponsorship signs which would need to be of a uniform appearance, the CEO advised that she was in discussion with Travis Perkins to ascertain if they still wished to continue with their sponsorship of the roundabouts using a standardised sign. Members were advised that if the organisation did not wish to continue a second organisation had expressed an interest in sponsoring the roundabouts; said interest would then be pursued and the sponsorship payment refunded to Travis Perkins. Noted.

8. HIGHWAY CORRESPONDENCE


• Letter from Gloucestershire County Council re. waiting restrictions – various roads in the Forest of Dean, including Lydney. Noted.

13. <u>LYDNEY TOWN COUNCIL: REPRESENTATION AT FOREST OFDEAN</u> DISTRICT COUNCIL PLANNING MEETINGS/APPEAL HEARINGS

Members were asked to consider if they wished to "stand on" with the Committee's previous resolution that the Council would continue with the CEO formulating the Council's verbal response from the minutes of the Committee meeting where the application was originally discussed and would discuss/embellish in line with known material considerations, as considered appropriate by Committee, in consultation with the Member who was to present said report.

Members were also asked to consider their previous resolution that the Council would register to speak on any/all relevant Lydney Planning Applications.

A number of Councillors spoke in support on continuing with the aforementioned arrangement; County Cllr Preest expressed his disappointment that Gloucestershire County Council had been prevented, as Lead Local Flood Authority, from speaking on an application in said capacity due to the application being submitted three weeks prior to the Authority taking on the role. Furthermore, County Cllr Preest advised that the County Council had elected to take on two additional officers to handle the volume of work which the new responsibility would create across the County.

After a short discussion it was **proposed by Cllr Preest**, **seconded by Cllr Pearman**, that Cllr Preest would be registered to speak on behalf of the Town Council concerning application P0361/15/OUT which would be discussed at the District Council's Planning Committee meeting which would take place the following day. Unanimous.

It was then **proposed by Cllr Pearman**, **seconded by Cllr Openshaw**, that the Council would "stand on" with both its aforementioned resolutions. Unanimous.

14. FORWARD PLANNING

Prior to the meeting Members were provided with a copy of an e-mail exchanged between the CEO and the Group Manager – Planning and Housing, Forest of Dean District Council, regarding a meeting to aid Members' comprehension of the District Council's vision/planning services for the Town.

It was anticipated that the Officer and the relevant Cabinet Member would attend the September Planning and Highway Committee meeting.

16. COUNCILLORS REPORTS

Cllr Vaughan noted that the Executive Officer had ascertained which organisation was responsible for cutting grassed areas outside Severnbanks School and the junction of Severnbanks Avenue, however, she expressed concern over the County Council's decision to only cut the grass a small number of times per year.

Members noted that the Executive Officer was in the process of compiling a map illustrating which organisation undertook grass cutting in the Town and the CEO advised that the matter would be a future agenda item for the Amenities Committee in order that they may consider if they wished to undertake any further grass cutting work in partnership with Gloucestershire County Council.
