### 4. MINUTES OF PREVIOUS MEETING

#### 5. **OPEN FORUM**

Mr W Owen, 3 Augustus Way, Lydney – started to voice a question concerning fire exits. However, Mr Owen was reminded that under the Council's Standing Orders questions needed to relate to an agenda item; as fire exits were not an agenda item no further discussion could take place.

## **HIGHWAY, FOOTPATH AND TRANSPORT ISSUES**

#### 6. SIGNAGE

County Cllr Preest advised that a meeting between himself, the CEO, Cllr Pearman and Mr B Watkins, Local Highway Manager, Gloucestershire County Council would take place W/C 15 June 2015 during which clarification would be obtained on the outstanding J D Norman signage.

County Cllr Preest then gave an overview of the work which had been completed with the £20,000 funding which had been allocated to each County Cllr for highway projects; highlighted projects which should be undertaken in the following year but stressed that he would obtain clarification from Mr Watkins during their impending meeting.

#### Lydney In Bloom

Prior to the meeting Members were provided with a copy of the e-mail exchange with Officers from Forest of Dean District Council regarding the stipulation that the Council was required to submit a formal application for advertisement consent in respect of sponsorship signs for floral displays. Members were advised that contact had been made with other authorities and Gloucestershire Market Towns Forum who were supportive of Councils' who sought to defray the cost to the public purse for floral displays through sponsorship arrangements.

Attention was drawn to the stipulation that the Council was required to provide a cheque for the sum of £192.50 to cover the required planning fee, should Members wish to proceed. Cllr Preest felt that the decision by Forest of Dean District Council went against the ethos of Localism and requested the CEO to send a strong e-mail enquiring what steps said authority was taking to combat flyposting which was occurring in the Town.

During discussion it was noted that the charge levied for sponsorship of floral displays covered the cost which would be incurred by the Council for planting. Members were also apprised of the sponsorship scheme which was operated by Tetbury Town Council. It was **proposed by Cllr Vaughan** that the Council would submit a formal application in respect of Advertisement Consent. Cllr Greenwood proposed an amendment that the Council would initially submit one application to cover its three floral sponsorship areas (e.g. roundabouts, gateways, wildflowers); however, individual applications would be submitted if the Council's initial application was declined by Forest of Dean District Council. Cllr Vaughan agreed to accept the amendment to her motion. **Seconded by Cllr Pearman.** Unanimous.

# 7. TRANSPORT/INFRASTRUCTURE/A48 Meeting Overview

Cllr Pearman provided a précis of the A48 Meeting during which all present agreed that the road itself was not dangerous, but the manner in which some people drove was thought to be.

Responding to a question raised by Mr Stockham, Cllr Pearman advised that no discussion took place on engineering gateways at the areas where most accidents occurred.
